The Sanlam Escalating fund invests in the corresponding Investec Equity Fund and cash. When the performance of the Investec Equity decreases, the percentage allocated to cash will increase. When the performance of the fund increases, the percentage in cash will decrease and the percentage in the Investec Equity Fund will increase.


