Fund Objective

This is a cautiously managed fund of funds which broadly adheres to the strategic asset allocation (houseview) of Sanlam Investment Management. The fund aims to deliver a high level of income with moderate capital growth targeting CPI+3% over any rolling 3 year period. A maximum of 40% of the fund will be invested in equities (both local and offshore). This fund is managed in accordance with legislation governing pension funds and may hold up to 45% of its assets offshore.

Fund Strategy

This fund will only invest in collective investment schemes managed within Sanlam's investment cluster. The fund is diversified across equities, bonds cash, listed property and offshore assets giving the investor exposure to the best investment expertise within Sanlam Investments both locally and abroad and in line with its cautious risk profile.

Tax Free Unit Trust

This fund qualifies as a tax free investment according to section 12T of the Income Tax Act, with effect from 1 March 2015. South African individuals qualify for the associated tax benefits namely no tax on dividends, income or capital gains whilst still enjoying all the benefits of a unit trust. Note contributions to tax free investments are limited to R36 000 per tax year, with a lifetime limit of R500 000. Amounts invested in excess of these permissible thresholds are taxable.


