When the performance of the Diversified Wealth Builder Fund decreases, the percentage allocated to cash will increase. When the performance of the fund increases, the percentage in cash will decrease and the percentage in the Diversified Wealth Builder Fund will increase.

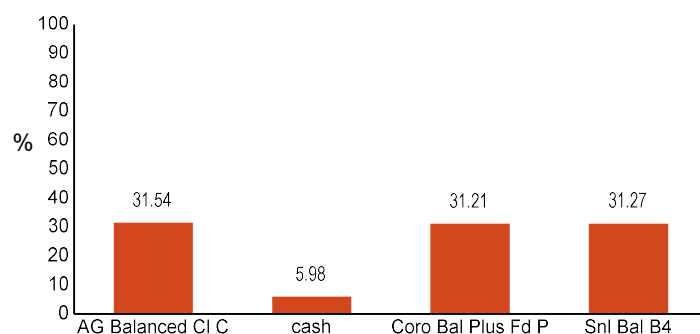
