When the performance of the fund increases, the percentage in cash will decrease and the percentage in the Diversified Wealth Builder Fund will increase.

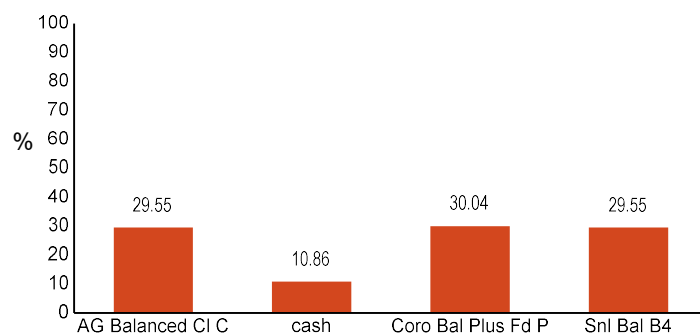
