When the performance of the fund increases, the percentage in cash will decrease and the percentage in the Coronation Equity Fund will increase.

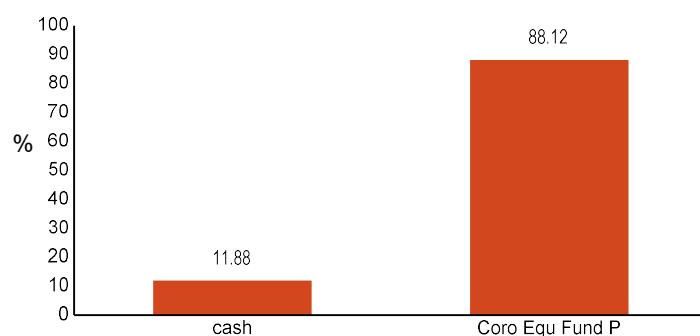
