This ensures that, at all times, the investment has some protection against adverse market conditions.

The Sanlam Escalating fund invests in the corresponding SIM Balanced Fund and cash. When the performance of the SIM Balanced Fund decreases, the percentage allocated to cash will increase. When the performance of the fund increases, the percentage in cash will decrease and the percentage in the SIM Balanced Fund will increase.

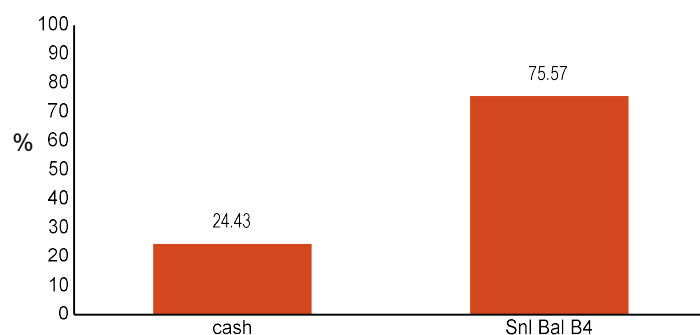
