Fund Overview

The Fund invests in global government inflation-linked bonds complemented by select allocations to high-quality corporate inflation-linked bonds. The Fund's global remit means that the manager can target the countries where inflation protection is most attractively priced and enables the Fund to benefit from bond features that do not exist in the UK, such as deflation floors. We view global inflation-linked bonds as being similar to a type of insurance – all diversified portfolios should have some exposure to them, in our opinion, due to their low or negative correlations to equities.



Geographic Allocation




Management Team

Additional Information

Risk Factors

The track record shown includes all historical performance from the previous ISIN. The fund objectives remain unchanged.

The Fund is managed by Sanlam Asset Management (Ireland) Limited, Beech House, Beech Hill Road, Dublin 4, Ireland, Tel + 353 1 205 3510, Fax + 353 1 205 3521 which is authorised by the Central Bank of Ireland, as a UCITS Management Company and Alternative Investment Fund Manager, and is licensed as a Financial Service Provider in terms of Section 8 of the South African FAIS Act of 2002. Sanlam Asset Management (Ireland) Limited. Sanlam Asset Management has appointed Sanlam Investments UK Ltd as Investment Manager to this fund.

Benchmark

The Fund does not measure its performance relative to a benchmark. The Fund is actively managed and will seek to achieve its investment objective by investing the majority of its Net Asset Value in debt securities including, inflation linked bonds issued by sovereign governments and corporate entities and nominal bonds (unless market conditions, in the opinion of the Investment Manager, dictate that the Fund should hold a majority of its Net Asset Value in cash or ancillary liquid assets (including money market instruments such as bank deposits and treasury bills) and only for so long as market conditions so dictate)). The bonds may be index-linked and may be fixed or floating rate. At least 80% of the Fund's net assets shall be invested in inflation linked bonds.

Previously benchmark returns for the Morningstar Gbl Trsy Inf-Lnkd GR Hdg GBP index have been included, however taking into account the above and the unconstrained basis of the fund, these benchmark returns have been removed as of March 2024.

Effective Annual Disclosure

The Effective Annual Cost (EAC) is a measure which has been introduced to allow you to compare the cost you incur when you invest in different financial products.
