

Fund Objective

The primary performance objective of the portfolio is to obtain as high level of current income as is consistent with capital preservations and liquidity. Capital gains will be of an incidental nature.

Fund Strategy

The fund aims to achieve this by investing in graded short-term money market instruments. The fund invests principally in cash, deposits and money-market instruments. The fund has a maximum weighted duration of 90 days. The fund is managed according to the guidelines set out in Regulation 28 of the Pension Fund Act and Regulation 29 of the Medical Aid Schemes Act. This Fund is suitable for retirement and medical aid investment.

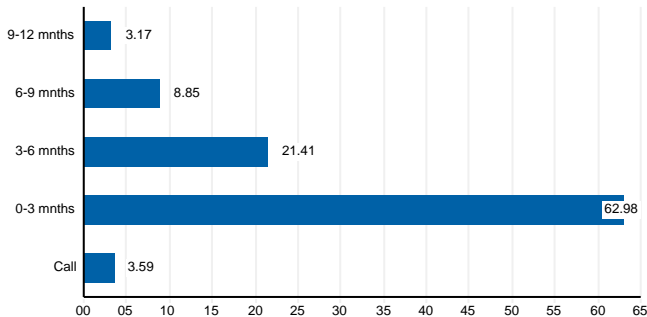
