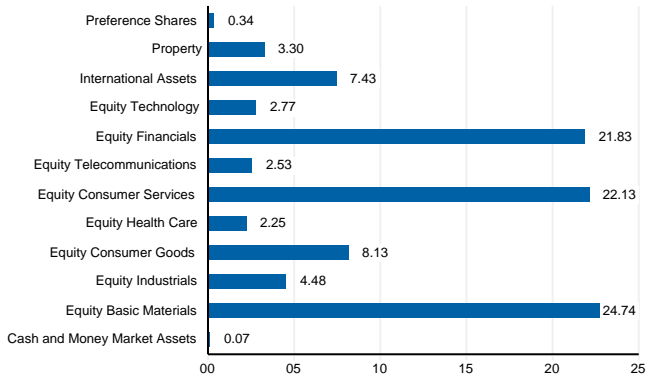

Risk Profile (Aggressive)
