This fund is suitable for investors who can withstand potential capital volatility in the shorter term. The fund may also invest in participatory interest (units) of collective investment schemes.

This fund aims to outperform the FTSE/JSE Capped SWIX Index through active stock selection across all sectors and market capitalisation on the JSE. The fund may at any time hold a maximum of 45% in offshore assets.


