

Fund Objective

This is an aggressively managed fund of funds which adheres to the strategic asset allocation (houseview) of Sanlam Investment Management. The fund aims to deliver long term capital growth with less volatility than an equity fund. A maximum of 60% - 75% of the portfolio will be invested in equities at any time (both local and offshore). This fund is Reg. 28 compliant and may hold up to 30% of its assets offshore.

Fund Strategy

This fund will only invest in collective investment schemes managed within Sanlam's investment cluster. The portfolio is diversified across equities, bonds, cash, listed property and offshore assets giving the investor exposure to the best investment expertise within Sanlam Investments both locally and abroad and in line with its aggressive risk profile.

Tax Free Unit Trust

This Fund qualifies as a tax free investment according to section 12T of the Income Tax Act, with effect from 1 March 2015. South African individuals qualify for the associated tax benefits namely no tax on dividends, income or capital gains whilst still enjoying all the benefits of a unit trust. Note contributions to tax free investments are limited to R33 000 per tax year, with a lifetime limit of R500 000. Amounts invested in excess of these permissible thresholds are taxable.

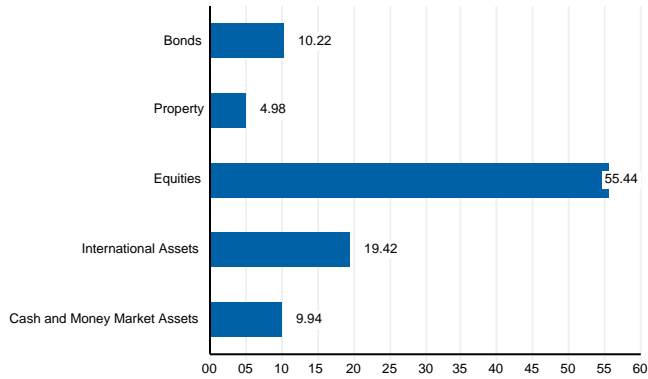

Risk Profile (Aggressive)
