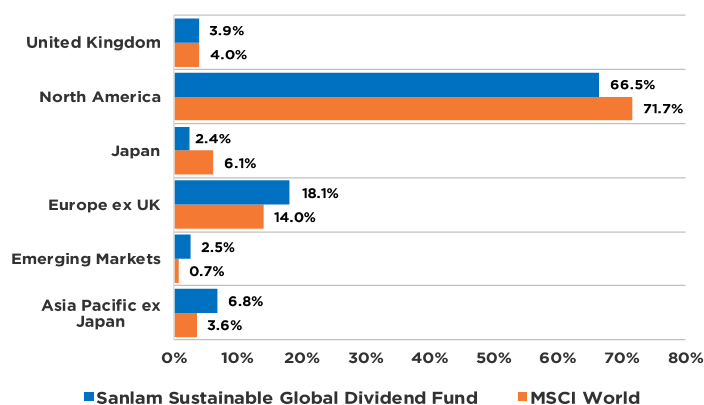

## Fund objective and policy

The investment objective of the Sanlam Sustainable Global Dividend Fund (the “Fund”) is to achieve (after deduction of costs) growth in both income and capital over rolling five year periods, whilst delivering a yield higher than that of the MSCI World Index (the “Benchmark”) and maintaining a MSCI ESG rating of AA or above.

The Fund is actively managed and invests at least 90% of the Net Asset Value of the Fund in stocks and shares of companies listed on stock exchanges globally and which are considered by the Investment Manager to operate sustainably. Whilst the Fund’s investment policy will not be subject to any market capitalisation bias or any particular geographical or sectoral restrictions, investment in companies that are involved in, and/or derive significant revenue (more than 10%) from certain industries or product lines are excluded.

## Effective annual cost

The Effective Annual Cost (EAC) is a measure which has been introduced to allow you to compare the cost you incur when you invest in different financial products.
