

Strategy objective

Achieve net annualised returns of Cash + 8% over rolling three year periods. The investment objective is pursued irrespective of the performance of the financial markets or any particular asset class.

Strategy characteristics

The strategy is a collective investment scheme in hedge funds, specifically a Retail Hedge Fund. The Fund pursues opportunistic, directional, relative value and correlation strategies in South African fixed income and related derivative markets. Investments of the portfolio will be subject to the provisions and limitations of Board Notice (BN) 52 of 2015.

This strategy is managed by Matrix Fund Managers, a diversified asset manager with a team of highly qualified and skilled investment managers boasting more than 140 years' collective experience.

The Investment Manager identifies investment opportunities through macro-economic forecasting and rigorous analysis of the term structure of interest rates. The Fund's investment strategies invest independently, with no house view approach adopted.
